





# Zenith Live 2024 Mumbai Attendee Overview



#### Terms & Conditions Zscaler and Sponsor accept and bind themselves the following terms and conditions:

If this Agreement is executed by the Company after August 15, 2025, payment for the Total Fee will be due and payable immediately upon receipt of an invoice for the same. Sponsor's failure to pay fees when due will result in termination of this Agreement and Sponsor will not be able to participate in Zenith Live 2025 Mumbai. Fees are non-refundable except as provided in the section below titled "Termination By Sponsor or Zscaler".
